Parking Lot Safety

Personal Safety

- Plan for how you will respond when approached by a stranger.
- Ask for security to escort if you feel unsafe. Avoid walking alone if possible.
- Check your car before getting in.
- Report to maintenance if you notice lighting out.
- Have keys out before getting to the car & be prepared to use the panic button if needed.

Property Safety

- Park in a well-lit area if possible.
- Do not leave valuables within view inside the car.
- Do not store an extra key under the car/fender/etc.

Pedestrian Safety

- Be cautious & aware of surroundings while in the parking lot.
- Use sidewalks & crosswalks when available. Look both ways before crossing.
- Avoid areas where it will be difficult for a driver to see you.
- In bad weather, wear proper footwear to provide adequate traffic to avoid slipping or falling.
- Report any uneven surfaces such as covers missing over manholes, chips in the asphalt, etc. to maintenance.

Driver Safety

- If possible, pull all the way through parking spots so that you don't have to reverse when leaving.
- Avoid distractions while driving.
- Keep a low speed limit. Abide by posted speed limits. Consider stopping distance in poor weather.
